TRYC By-Law 27.01 A Senior Members

A Senior Member shall be an accepted applicant who owns or who has owned, within the past two (2) years, a vessel of a size and type approved by the Board, and maintains a principal docking location within the Thames River Yacht Club basin or at their principal residence within 3 kilometers of the Thames River Yacht Club basin.

He/she shall be entitled to the entire privileges of the club. He/she shall have the right to attend and have a vote at all meetings of the Corporation understanding always that there shall be but one vote per vessel, and to hold office.

Vessels owned in partnership shall declare the Senior Member of record in writing and deposit same with the Secretary. The Senior Member of record shall have the vote as herein described except in his/her absence, in which case the vote may be cast by the other partner. Except with the approval of the Board, declarations may be made only once per year.

The spouse or partner of any Senior Member has the right to vote at a general meeting in the absence of his/her spouse or partner and the right to serve on the Board of Directors non-currently with his/her spouse or partner for a term. The spouse or partner holding office shall exercise the voting right during the currency of the office.

During the first year of membership you will be a probationary member but have all senior member benefits. The Board will determine your eligibility for acceptance as a senior member in early September of your first year. After you achieve senior membership status, you will receive a TRYC burgee which you may fly.

SENIOR MEMBERSHIP FEES (Subject to change at any time):

- a) **Initiation Fee***: \$100 +HST A one-time fee payable on application.
- b) **Membership Dues***: \$150 +HST payable on application. Annual dues and fees to be determined from time to be determined from time to time by resolution of the Board of Directors.

c) **Dockage***:

- e) **Haul-out and launch fees***: The cost of renting a crane will be shared fairly by the club members. This includes haul-out, launch and bottom washing and is payable twice a year at the time of haul-out and launch. <u>25,000 lb Weight limit</u> for Haul-out at TRYC.

f) **Work Hours Deposit:** Each Spring Senior Members are billed a \$3030001 deposit which converts to a credit on your account upon completion of 15 hours volunteering at the club during the season.
